While admirable we realize the odds of all 701 homes offering their volunteer service are higher than winning the mega millions lottery. Many neighbors have been asking who CKIA uses for trash service. CKIA recommended Pro Disposal (now Waste Connections) 4 years ago and made a gallant effort to move to everyone using the same company through the one truck initiative. In an effort to cut down on trash truck traffic and trash cans being left out across the community for much of the week. Currently Waste connections services 81% of the neighborhood 573 households. Here are some costs based off my limited research:

Waste Connections \$317.00 Annually- Tuesdays and Wednesdays pickups

Republic services \$416.00 Annually - Tuesday pick up

Waste Management \$505.00 Annually - Thursday pickups

I once heard a story where a neighbor remarked to a new neighbor in a cul-de-sac that Waste Management has to drive in their cul-a-sac, back up and pull forward every week and that's a lot of wear and tear on the street for one house. That new neighbor switched to the one truck initiative. I encourage everyone to take a good look at their trash service. Maybe consider moving to a company who picks up on Tuesdays and Wednesdays.

# Nobles re-IMAGINED

In addition to annual dues, this year we are requesting an additional capital contribution to help fund a new landscape improvement project at Arapahoe Road and Nobles Road. These improvements represent the culmination of nearly two decades of planning by the CKIA Long Range Planning Committee.





CKIA's Long Range Planning Committee (LRPC) was established nearly two decades ago to help Cherry Knolls' public-facing spaces reflect the quality of the community. This is widely thought to help boost individual property values. CKIA's LRPC has worked hard to maintain and improve our community. With nearly all of the perimeter now

improved through implementation of the plan, the last major component is now ready to be checked off the list: the Nobles Road and Arapahoe Road entrance to our neighborhood. This land was deeded to our community in 2022 by the City of Centennial. As a result, we can pursue improvement without risk that the City may subsequently alter that investment.

The originally adopted long-range plan for this parcel included a parklike setting with a significant amount of Kentucky Bluegrass and other less drought resistant vegetation. In 2017, the LRPC stepped back and reevaluated this plan, due to a tier two water shortage and future restrictions of the Colorado River Basin and the significant maintenance and watering costs that CKIA pays for Cherry Field.

The LRPC spent the last five years consulting with experts in the field and reviewing multiple proposals to develop a beautifying plan that incurrs less maintenance and water. They found the answer in using native drought-resistant vegetation to highlight this primary entrance and enhance the beauty of the community.

CKIA is proud to be developing this land parcel in a sustainable



At the May 2022 General Board Meeting the LRPC presented their recommended concept, introduced by Ransom Beegles of R. Design Landscaping Architecture.

The Board unanimously approved the concept to move forward to a full set of plans to be bid and presented at the November General Meeting. On December 13, 2022, Beegles and your LRPC presented the final plan to beautify this parcel of land. Irrigation is required to establish this landscape for the first two to three years, then CKIA will cut the water back to supplemental water, only when needed in extreme circumstances. The LRPC will work on plan approvals with the City and Denver Water over the coming months. Our goal is to complete this project by 2024, if not in 2023, so we can finally see our newly acquired land in all its glory.

This project is estimated to cost our community \$200,000 to \$250,000.

While these costs may seem high, this plan was approved by our community nearly two decades ago, at approximately \$150,000 with no consideration of the future cost of water and maintenance requirements. CKIA is asking for your financial support to help us with the costs outside of regular dues. CKIA has set aside approximately \$150,000 in our account towards this improvement. CKIA is asking for your financial support to help with the costs beyond regular dues.

## **Centennial City Council Update**

There are so many great things happening in Centennial, I hope I can get it all in.

The City of Centennial has partnered with the YMCA to provide activities for our Seniors and Youth. They are going to have over 6,000 sq feet of space at the Streets at Southglenn, just down from the library, so it will be easily accessible from the parking garage. The programs for seniors will include Nutrition, Health and Wellness, Senior Isolation, Silver Sneakers and so much more. The youth programming will include Leadership in Training, Model UN and E-Gaming.

They have worked with both our Senior and Youth Commissions to develop these programs and also have surveyed the community to ensure they are designing programs that people are interested in. The soft launch will begin in March and they should be fully operational by summer. You don't need to be a member of the YMCA to enjoy these programs, and the fees for Centennial residents will be at a discounted rate. I am looking forward to this wonderful inter-generational space and I hope many of you will take advantage of the programs they will offer. The YMCA will have a Centennial page on their web site and, of course, the Centennial web site will also have a link to all of the programs.

In December, Centennial adopted a 25 mile per hour limit on all of our residential streets. Our traffic engineers found that we had discrepancies throughout the city without any engineering reason for the different speed limits. We will change the signs over the next few years. We are also launching a new yard sign program that neighbors can put up to remind folks to slow down. They are very bright and have fun sayings, my favorite being, "Drive like your Mom lives here and she's watching". This will require a neighbor to spearhead getting permission from those on your street to put up a sign, pick up and return the signs and complete some paperwork. The goal is to have the signs up for about a week so that driver's notice them and then return the signs to the City.

Housing is a hot topic in our state and Centennial has completed a year long housing study thanks to a grant from the Department of Local Agencies. I participated in the housing working group and the findings can be found on the Centennial web site. We started the process with 9 strategies and are now down to 5. Our consultants are working with staff to come up with land development code changes that will be presented to Planning & Zoning and Council this year.

Want to get involved? We are currently taking applications for our Boards & Commissions, The Centennial State of the City will be held on Thursday, May 11th. Centennial 101 is back but dates haven't been announced, and we will have a full line up of summer events such as Brew & Que and Centennial Under the Stars. The best way to find out what is happening is signing up for our newsletters or following the City of Centennial's social media accounts.


